Introduction & Instructions

This checklist is the recommended minimum standard to ensure safety of both **competitive and recreational activities** of Australian Canoeing affiliates. Its purpose is to ensure that all appropriate steps have been taken to ensure the safety of participants in Australian Canoeing-sanctioned paddling activities.

How to use this checklist:

- When organising **trips and expeditions** – ***This checklist is all you need.*** Please refer to it when planning for a safe activity, and complete as required to confirm that all reasonable steps have been taken to ensure the safety of all participants.
- When organising **competitive events** – ***You need this checklist plus the relevant discipline-specific safety checklist.*** Please refer to both checklists when planning for a safe competitive event, and complete both as required to confirm that all reasonable steps have been taken to ensure the safety of all participants.

Requirements noted in this checklist are based on the following documents:

- Australian Canoeing Safety Guidelines – December 1 2004; and
- Member Protection By Law – effective July 1 2003.

You may find it helpful to have these documents on hand.

<p>6.2 Sun protection</p> <p>Do trip leaders and all competition participants adhere to and promote best practice sun protection behaviour, to include (as relevant):</p> <ul style="list-style-type: none"> <input type="checkbox"/> Sunscreen freely available to all participants <input type="checkbox"/> Regular use of high protection factor sunscreen on all exposed areas, with reapplication at least every 2 hours (more often when sweating or in spray/wet environments) <input type="checkbox"/> Regular use of a high protection factor lip balm <input type="checkbox"/> Use of a wide brim hat or a style that gives 360 degrees protection, tied on, OR (where helmets are used) use of a helmet with a visor (if available), and regular, liberal application of sunscreen <input type="checkbox"/> Long sleeve shirts with a collar, appropriate to the conditions, is worn (rash vests, thermal tops, cags, etc) <input type="checkbox"/> (In the event that legs are exposed for prolonged periods) regular, liberal use of sunscreen is a minimum. A full-length pant, of a fit and materials that is safe and comfortable for swimming, is preferable. <input type="checkbox"/> Eye protection from solar UV radiation is recommended.

Guides/Instructors are <u>not</u> qualified by virtue of their AC qualifications to determine the suitability of lake or river water for human consumption. The condition of water should be checked with the relevant body and if any concerns exist, water should be carried or an acceptable water purification method should be used.</i></p>
